Dear Senators:

Our national coalition of hospital-based nursing schools are writing in strong support of your legislation, S. S1568, the TRAIN Act (*Technical Reset to Advance the Instruction of Nurses (TRAIN) Act*). Amid a growing nursing shortage – and especially during the COVID-19 pandemic -- these schools are a desperately needed pipeline of highly skilled nurses to hospitals, nursing homes, community and home-based services and other providers across the nation.

Approximately 120 hospital-based nursing schools receive financial support from CMS Medicare pass-through funds to our host hospitals that support nursing and allied health education programs.

On August 21, 2020, CMS issued instructions to Medicare Administrative Contractors (MACs) to recalculate the Part C components of nursing and allied health (NAH) and direct graduate medical education (DGME) payments to hospitals for calendar years 2010 through 2019. This applies to all unsettled cost reports plus those settled within the past three years.

Because of an agency oversight, CMS did not make annual updates to the DGME Part C payments that fund the NAH Part C payment pool of up to \$60 million annually. To account for the missed updates, CMS has started recouping payments previously made to NAH programs since 2010. For some facilities, this may lead to a loss of as much as 70% of past payments, with additional reductions going forward. This significant funding cut will likely close some of our schools and will cause most of us to educate fewer students of nursing and allied health professions.

CMS understands the negative impact this will have on these nursing colleges, but it has no authority beyond recouping the payments.

The TRAIN Act repairs this technical regulatory glitch and will allow our schools of nursing and allied health to continue the important work of training America's nurses and allied health professionals.

We applaud your leadership and stand ready to work with you in securing passage of this important legislation.
